PRELIMINARY NOTIFICATION

Whereas it appears to the District Collector, Guntur that the lands specified in the schedule below are needed for a public purpose, to wit, for formation of Nadikudi – Srikalahasti B.G Line , notice to that effect is hereby given to all to whom it may concern in accordance with the provision of Section-11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act No.30 of 2013).

Chapter-II (Determination of Social Impact and Public Purpose) & Chapter-III (Special Provisions to safeguard Food Security) are exempted as per Subsection of 1 of Sec 10(A) of the Act as added by ordinance No.5 of 2015, dtd 30.05.2015 and published in District Gazette.

No families are likely to be displaced due to this land acquisition.

Now, therefore, in exercise of the powers conferred u/s -12 of the Act, the District Collector, Guntur hereby, designates the Revenue Divisional Officer, Narasaraopet his staff and workmen to exercise the powers conferred under the above said section.

Under section 11 (4) of the Act, No person shall make any transaction or cause any transaction of land i.e., sale/ purchase etc. or create any encumbrances on such land from the date of this Notification without the prior approval of the Collector.

Objections to the acquisition, if any, may be filed by the person(s) interested within 60 (sixty) days from the date of publication of this Notification as provided under section-15 of the Act before the Collector/ Land Acquisition Officer.
