The Addendum to Preliminary Notification U/s.11(1) of New L.A.RR Act 30 of 2013 for acquisition of land for formation of Nadikudi to Srikalahasthi New B.G.Line to an extent of Ac.0.18 cents in S.No.254/1C2 and 283/2B2 of Kubadpuram village of Rajupalem Mandal submitted by the Revenue Divisional Officer, Guntur in the reference 1st read above is approved and ordered for publication in the District Gazette and in two daily news papers.

The cost of acquisition in this case will be borne by the State Government.
